Article III

Amendments

3.1 Purpose of organization. Said corporation is organized exclusively for charitable, religious, educational and scientific purposes; including for such purposes, the making of distributions to organizations exempt under section 501 (c) (3) of the Internal Revenue Code of 1986 (or corresponding section of any future federal tax code.)

3.2 Earnings and Assets. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501 (c) (3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, of otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) Any political campaign on behalf of or in opposition to, any candidate for public office.

Notwithstanding any other provision in these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code (or corresponding section of any future federal tax code.)

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code or be distributed to the federal government, or to a state or local government for a public purpose.

3.3 Distribution of Assets. However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation, or corporation organized and operated exclusively for the purposes specified in section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future federal tax code).
