ARTICLES OF INCORPORATION

OF

(A Corporation Not For Profit)

I, the undersigned incorporator of  
(C.U.P., Inc.) of Tallahassee, Florida, being desirous of forming a corporation for charitable and philanthropic purposes under the provisions of Chapter 617, Florida Statutes, do hereby form this corporation not for profit and hereby agree and adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of this corporation shall be  
(C.U.P., INC.).

ARTICLE II

Address

The initial principle location of this corporation shall be Rt. 2, Box 4263 (27 Spring Creek Road), Crawfordville, FL 32327.

ARTICLE III

Purpose

The purpose for which this corporation is organized shall be to unite all Christ believing churches, groups and people through prayer, worship and evangelism.

ARTICLE IV

Qualification of Members

The Board of Directors shall be chosen at the discretion of the Founder and President on an annual basis. Members shall consist of those persons who subscribe to and support the goals and objectives of the corporation.

Term of Existence

This corporation shall exist in perpetuity unless sooner dissolved by its members or by operation of law.

Amendments may also be made at a regular meeting of the membership upon notice given, as provided in the by-laws, of intention to submit such amendments.

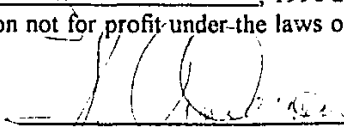
#### ARTICLE X
