ARTICLES OF INCORPORATION

of

FLORIDA DISABILITY EDUCATION AND ASSISTANCE FOUNDATION INC.

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

Article 1.

The name of the corporation is FLORIDA DISABILITY EDUCATION AND ASSISTANCE FOUNDATION INC., a NONPROFIT CORPORATION.

Article 2.

The principal place of business/office and mailing address is: 4307 N.W. 1st Terr, Broward County, Pompano Bch, Fl. 33064.

Article 3.

This Corporation has been established to provide education and disability entitlement enlightenment and education. Our goal is to assist the permanently disabled to secure aid in rehabilitation and support.

Article 4.

The initial directors will serve for two years. Under the bylaws the membership by general election shall select five directors. Two directors will be elected for the administrative staff and three from the membership at-large. Membership at large shall be all members of the foundation with at least sixty days membership on the day of the election. Nomination by members must be made of members seeking the position no less than twenty four hours of the election of the members at-large. The administrative slate will be selected by the full membership from the existing or proposed members of the administrative board. Further policies and election regulation will be contained in the BY-LAWS of the corporation.

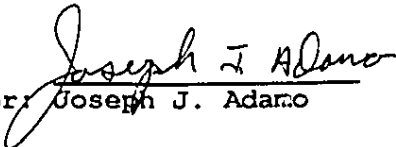

The number of directors may be raised or lowered by amendments of the bylaws of the corporation but shall never be less than three.

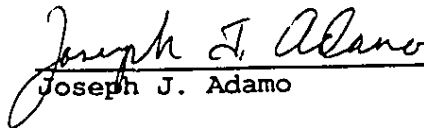
