ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

Osceola Service League, Inc.

ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

Osceola Service League, Inc.
P.O. Box 420211
Kissimmee, FL 34742

The principal place of business is in the private homes of OSL members. Members meet monthly, the second Tuesday of each month, in specified, member-owned private homes. Members volunteer the use of their homes to host monthly meetings. Osceola Service League does not own or rent any permanent structure to conduct business.

ARTICLE III

Purpose(s)

The specific purposes for which the corporation is organized are:

1. To form an organization through which our members can provide service to the community in the form of volunteerism, to foster involvement of our members in the community, and to seek out any needs in the community where there is an opportunity for the Osceola Service League to provide donations of food, clothing, holiday gifts, financial assistance, and volunteerism.
2. To sponsor fundraising activities, the proceeds of which benefit the community and provide for service projects. Those fundraising activities include but are not limited to:
 - Annual fashion show and luncheon
 - Annual candy sale
 - Raffle ticket sales of items donated by individuals/businesses and Osceola Service League members
 - Annual rummage sale of items donated by members of the Osceola Service League and individuals/businesses.

Those service projects include but are not limited to:

Annual \$500.00 scholarship to a graduating senior of an Osceola County High School.

Birthday card and cash gift to every child residing at the Osceola County Children's Home.

Annual Thanksgiving food baskets for 5-6 Osceola County families.

Annual Christmas gifts (clothing and food) for 5-6 Osceola County families.

Community Service fund for miscellaneous requests for donations and/or financial assistance.

Volunteerism at Give Kids The World and Osceola Children's Home.

ARTICLE IV

Manner of election of officers

The manner in which the directors are elected or appointed is as follows:

As stated in the by-laws

Article VII. Election of Officers

Section 1. A 3-member Nominating committee shall be formed at the October meeting. A slate of nominees shall be presented at the November meeting. All voting is to be by the majority vote of active members present and by written proxy received prior to the vote. Any member may call for a secret ballot.


