## PROPOSED ARTICLES OF INCORPORATION OF THE EDGENOOD BAPTIST CHURCH OF CHLANDO, FLORIDA

We, the undersigned, hereby associate ourselves for the purpose of forming and organizing and beginning a corporation not for profit under the Laws of the State of Florida and do hereby adopt, declare and subscribe the following as the Articles of Incorporation.

#### ARTICLE I

The name of this corporation shall be THE EDGENOOD BAPTIST CHUNCH OF ORLANDO, FLORIDA, and it shall be located in and have its principal place of business in Orange County, Florida.

#### ARTICLE II

The general nature of the object of this corporation shall be to advance the Christian Religion and particularly the Doctrines subscribed to and Believed in by other churches who are members of the Florida Baptist Convention and the Southern Baptist Convention, and to band together for the promotion of Religion and Morality and to further facilitate the carrying on of the work of said corporation.

#### ARTICLE III

The qualifications of the members of said corporation and the manner of their admission shall be determined by any one of the following ways: (1) by the giving of satisfactory proof of conversion to the Christian Faith, namely upon the profession of faith in Christ as the Saviour, Lord, and Haster; beptism by immersion and acceptance by the majority of the members of said corporation present and voting at the time of the reception of such members; provided, however, that all persons who are now members of the Edgewood Baptist Church of Orlando shall be and remain members of said corporation whether or not their names are subscribed to this proposed charter; until dismissed for cause by a majority of members of said corporation present and voting at the time of such dismissal. (2) on presentation of letters of dismission and recommendation from other Churches of like faith and order. (3) on a statement of satisfactory avidence of Christian character and former affiliation with a Church of like faith and order, in the event of failure to produce a letter of dismission. (4) under the watch care of the Church pending receipt of a regular letter of dismission.

#### ARTICLE IV.

The existence of this corporation shall be perpetual.

#### ARTICLE V.

The affairs of the corporation are to be managed by the following officers, to-wit:

(1) By a Board of Deacons composed of eight (8) or more members, as the circumstances and wishes of the church members may determine, the Pastor of the Church being ex-officio member of the Deacons. The Board of Deacons shall have full charge, power and supervision over the affairs of said corporation except insofar as the powers which are specifically delagated to the Church Trustees herein shall be concerned, u The said Board of Deacons may delegate such activities of the corporation as they may deem proper, to committees, or departments as may be created by the church in conference.

- (2) By a Board of Trustees composed of six (6) or more members, who shall make and execute all contracts, deeds, bonds, notes, negotiable instruments, mortgages, trusts and all other instruments of indebtedness or conveyance of said corporation upon the order thereof, by resolution duly adopted for such purpose; provided, however, that all such documents may be signed for and on behalf of the Board of Trustees by its Chairman, one other member of the Board of Trustees, and attested by the Church Clerk. The title to all property, however, shall be vested in the name of said corporation.
- (3) By such other officers as the Church or corporation may from time to time see fit to elect, and such other committees as may be authorized by vote of the Church sitting in conference.

#### ARTICLE VI

- 1. All Officers and Committees of the Church shall be elected at the Annual business meeting of said Church to be held beginning at 8:00 P. M. on Wednesday evening after the second Sunday in September of each year. Those present at said annual meeting may adjourn the same by a majority vote to another date certain, and in such manner as may be designated in the By-Laws; provided the Pastor shall be elected by majority vote of the members present and voting in any meeting called for that purpose for an indefinite period unless otherwise designated in the By-Laws.
- In the event of a failure to hold an annual election, the current church officers and committees shall continue to serve until the beginning of the next Church year.
- The Board of Deacons shall be elected for a period of four (4) years, and one-fourth shall be elected each year. At the first annual business meeting one-fourth of the Board of Deacons shall be annual business meeting one-fourth of the Board of Deacons shall be elected for a term of one year and one-fourth of the Board of Deacons shall be elected for a term of two years and one-fourth of the Board of Deacons shall be elected for a term of three years and one-fourth of the Board of Deacons shall be elected for a term of four years, be elected for a term of four years. No Deacon shall be eligible vo succeed himself until after he has been out of office for a period of at least one year.
- 4. All other officers shall be elected at the annual meeting to serve for a period of one year. In case of vacancy in the Board of Deacons, the Board of Trustees, or any office in said corporation, such vacancy shall be filled by an election held by the members of said corporation, after the time and place of such election has been first publicly announced at any regular Sunday service.

#### ARTICLE VII

The affairs of said comporation shall be managed by the following officers until the first regular election, unless the memberahip of said corporation shall see fit to increase the number of the ship of said corporation shall see fit to increase the number of the Board of Deacons or the Board of Trustees: Rev. Spurgeon N. Hinds, Pastor; M. S. Burton, J. Davis Bulluck, Jr., A. C. Whitson, A. H. Clarke, Percy C. Lane, Jr., James L. Easton as the Board of Deacons; T. A. Scott, Jr., Donald Christopher, R. S. McCalla, Harley K. Dulsney, Ermie Cain, James L. Easton as the Board of Trustees and Directors, R. S. McCalla as President of the Board of Trustees and Directors, Harley K. Dulancy as Vice-President of the Board of Trustees and Directors, Ermie Cain as Secretary-Treasurer of the Board of Trustees and Directors.

#### ARTICLE VIII

The said corporation may adopt a system of rules and By-Laws which shall be approved by the members of the corporation sitting

in conference. The By-Laws may be changed, altered, modified, revoked or smoulled at any time by a majority vote of the members of said corporation sitting in Church conference.

#### ARTICLE IX

The highest amount of indebtedness or liability to which said corporation shall at any time subject itself, shall be \$300,000.00, provided that such limitation shall not apply to indebtedness incurred in connection with the purchase of property or the construction of buildings or the borrowing of money for any type of physical improvement to church property.

#### ARTICIA X

This corporation shall be entitled to hold real estate of a value of not exceeding \$750,000.00, subject always to the approval of the Circuit Judge.

#### ARTICLE XI

The Constitut on of this Church may be amended at any time by a majority vote of the members sitting in conference and voting, provided notice of such amendment or revision is publicly announced at any regular Church service, two (2) weeks prior to a regular or opecial church conference, and such action approved by the Circuit Court in and for Orange County, Florida.

#### ARTICLE XII THE CHURCH YEAR

The Church year shall extend from October 1 through September 30 of each year.

#### ARTICLE XIII

The Church sitting in conference shall be the final authority in all of its affairs.
