We, the undersigned, hereby organize a corporation not for profit under Chapter 617, Florida Statute, and in evidence thereof submit the following proposed Charter to the Honorable Secretary of State, State of Florida.

Article I

The name of this corporation shall be FLORAHOME UNITED METHODIST CHURCH, INC. The place where this corporation is to be located is in the city of Florahome, in the County of Volusia, and in the State of Florida.

Article II
