ARTICLE II- PURPOSE

The purposes of which this Corporation is organized are exclusively for charitable, religious, educational, and scientific purposes including for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.

ARTICLE IX-DISSOULTION

Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
