Articles of Incorporation

of

We, the undersigned, being desirous of forming a corporation, not for profit, for religious and charitable purposes, under the provisions of Chapter 617, Florida Statutes, do hereby propose and subscribe the following Charter:

ARTICLE I

The name of the corporation shall be:

ARTICLE II

The general nature and the objects of the corporation shall be religious, charitable, and such other, as are generally carried on by conservative, Protestant Churches of the United States; to organize, maintain, operate and conduct such Churches, departments or agencies, so as to carry out the above mentioned purposes; to own, control, lease, purchase or take by gift, devise, bequest or otherwise, and to convey, dispose, encumber, lease and to do all things and exercise all

ARTICLE IV

The method of election of directors shall be stated in the Corporation's Bylaws.
