

ARTICLES OF INCORPORATION  
OF  
P. K. YONGE PARENTS' ASSOCIATION, INC.  
(A Florida not for profit corporation)

THE UNDERSIGNED, of lawful age, and a resident of the State of Florida, does hereby form a corporation under the "corporations not for profit" provisions of the State of Florida (Chapter 617, Florida Statutes 1996).

ARTICLE I

NAME: The name of the corporation is P. K. YONGE PARENTS' ASSOCIATION, INC.

ARTICLE II

PRINCIPAL OFFICE: The street address of the initial principal and the mailing address of the corporation is 224 SW 2nd Avenue, Gainesville, Florida 32601.

ARTICLE III

TERM: The term of the corporation shall be perpetual.

ARTICLE IV

PURPOSE: The purposes for which this corporation is organized are as follows:

1. To act as the fund raising group for students who attend P.K. Yonge Developmental Research School.
2. To be the governing body of the parents of students who attend the elementary school.
3. To act in the general best interest of P. K. Yonge

students.

#### ARTICLE V

POWERS: The corporation shall have the power to perform any act authorized to be performed by a non-profit corporation under the laws of the state of Florida.

#### ARTICLE VI

STOCK: The corporation shall be non-profit and no stock shall be issued or authorized.

#### ARTICLE VII

MEMBERS: The qualification for members and the manner of their admission shall be as stated and regulated by the bylaws of the corporation.

#### ARTICLE VIII

BOARD OF DIRECTORS: The corporation shall be governed by a Board of Directors, members of which shall be elected in the manner provided in the bylaws. The number of persons constituting the initial Board of Directors shall be four (4) and their names and addresses are as follows:

The above named persons shall serve until the first annual election.

#### ARTICLE IX

BYLAWS: The power to adopt, alter, or amend bylaws shall be vested in the Board of Directors.

#### ARTICLE X

AMENDMENTS TO ARTICLES OF INCORPORATION The Articles of Incorporation may be amended by the majority of the members of the corporation at any regular or special meeting. Amendments to the Articles of Incorporation may be proposed by any number of by any director.

#### ARTICLE XI

INCORPORATOR: The name and address, including street address and number, of the original incorporator and subscriber to these articles is: H. Stephen Pennypacker, 224 SW 2nd Avenue, Gainesville, Florida.

#### ARTICLE XII

REGISTERED AGENT: The street address of the corporation's initial registered office is 224 SW 2nd Avenue, Gainesville, Florida 32601 and the initial registered agent is H. Stephen Pennypacker.


#### ARTICLE XIII

DISSOLUTION: This corporation is not organized for pecuniary profit. In the event of dissolution of the corporation, all its assets remaining after the payment of all debts and obligations of the corporation shall not inure to the benefit of any member, director, officer, or individual by shall be distributed to such one or more organizations which have purposes and objects similar

to this corporation and are exempt from United States income taxes, as the Board of directors may select, and if more than one, in such shares and proportions as the Board of Directors may determine.

**ARTICLE XIV**

**SUBORDINATION:** The corporation shall be subordinate to and subject to the authority of the University of Florida.
