ARTICLES OF INCORPORATION OF
RONNIE A. ROWAN MINISTRIES, INC.

The undersigned, for purposes of forming a corporation not for profit under Chapter 617, Florida Statutes, do hereby adopt the following articles of incorporation:

ARTICLE ONE: NAME

The name of the corporation is RONNIE A. ROWAN MINISTRIES, INC.

ARTICLE TWO: CORPORATE DURATION

The duration of the corporation is perpetual and shall commence upon filing.

ARTICLE THREE: PURPOSE OR PURPOSE

The general purpose for which the corporation is organized is to establish and operate a religious ministry; however, this corporation shall also have the right to engage in any endeavor which is permissible for non-profit corporations and to transact any other lawful business in which non-profit corporations may engage, which can, in the opinion of the board of directors, be advantageously carried on in connection with or auxiliary to the operation of the religious ministry.

ARTICLE FOUR: MEMBERSHIP

All provision relating to membership in the corporation and termination of membership shall be established in the bylaws.

ARTICLE FIVE: REGISTERED AGENT

The street address of the initial registered office of the corporation is 326 Spikes Road, Southport, Florida 32409, and

ARTICLE SIX: DIRECTORS






