## Articles of Incorporation

of

### Children of Krishna, Inc.

The undersigned, acting as incorporators of a corporation pursuant to chapter 61%, Florida Statutes, adopt the following Articles of Incorporation:

#### Article I Name

The name of the corporation shall be Children of Krishna, Inc.

### Article II Principle Place of Business and Mailing Address

The mailing address of this corporation shall be:

P.O. Box 238 Alachua, FL 32616.

### Article III Purposes

The specific purpose for which the corporation is organized is:

To systematically propagate spiritual knowledge to society at large and to educate all peoples in the techniques of spiritual life in order to check the imbalance of values in life and to achieve real unity and peace in the world. These principles are derived from authorized Vedic literature as translated and presented by His Divine Grace A. C. Bhaktivedanta Swami Prabhupada, founder and preceptor the International Society for Krishna Consciousness (ISKCCL). The corporation will achieve this goal through the following specific activities related to the religious training and education of our children:

- (a) To raise the standards of all religious instruction provided in educational institutions of ISKCON;
- (b) To select and train qualified members of the ISKCON to implement the vision of His Divine Grace A.C. Bhaktivedanta Swami Prabhupada with respect to the religious training and education of children;

- d) To assess individua students, and as part of their religious training, provide equisite assistance and/or placements for them within the mission of ISKCON
- (e) With a view towards achieving the aforementioned purposes, to publish newsletters and pamphlets, to receive, administer, and distribute funds, and do all other things necessary and proper.

## Article IV Manwer of Election of Directors

The manner is which the directors are elected or appointed shall be stated in the by-laws of the corporation.

## Article V Limitation of Corporate Powers

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows:

- (a) This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) The corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible Section 170(c)(2) of the Internal Revenue Code.
- (c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

## Article VIII Distribution of Assets Upon Dissolution

The property of this corporation is irrevocably dedicated to religious and charitable purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious and/or charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
