ARTICLES OF INCORPORATION  
FOR

The undersigned, acting as incorporators of a Not For Profit Corporation pursuant to Chapter 617, Florida Statutes, Adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be:

ARTICLE II

The principle place of business and the mailing address of this corporation shall be:

ARTICLE III
