

to the above Court a proposed Charter for the incorporation of the
WEST SIDE UNIT OF JEHOVAH'S WITNESSES under Chapter 617 of Florida
Statutes Annotated and other acts relating thereto as a corporation
not for profit.

And we set forth the following:

1. The name of the corporation shall be WEST SIDE UNIT OF
JEHOVAH'S WITNESSES, and the place where it shall be located is 612
W. Union Street, in the City of Jacksonville, Florida, and or elsewhere
as the Board of Directors may from time to time determine.

2. The general nature of the object of the corporation
shall be to own, use, lease, convey, mortgage and otherwise deal and
handle real and personal property for the purpose of carrying on the work
of the Jehovah Witnesses, which is the teaching, propagation and
instruction of people in Christianity according to the faith of the
Jehovah Witnesses.

3. The qualification of members and the manner of their
admission shall be determined by the Board of Directors according to the
usage and practice of the Jehovah Witnesses.

4. The term for which the corporation shall exist is
ninety-nine years.

The officers and Board of Directors named in paragraph six hereof shall manage all the affairs of the corporation until the first election under this Chapter. Their successors shall be elected once each year at a time and place designated by the Board of Directors, with notice thereof sent to each member of the corporation at least ten days in advance. The officers and directors shall hold office until their successors are elected and qualified.

8. The Board of Directors shall make, alter and rescind the by-laws, but they shall at all times be in conformity with the faith, usage and practice of the Jehovah Witnesses.

9. The highest amount of indebtedness or liability to which the corporation may at any time subject itself shall never be greater than two-thirds of the value of the property of the corporation and in no case shall exceed one hundred thousand dollars.

10. The amount in value of the real estate which the corporation may hold shall never exceed one hundred fifty thousand dollars and shall be subject always to the approval of a judge of the Circuit Court of the Circuit in which Duval County is comprised.
