ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a nonprofit corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be Glorious Holiness Church of God, Incorporated.

ARTICLE II

Principal place of business and mailing address

The principal place of business of this corporation shall be 1014 "E" Street, Pensacola, Florida 32501.

The mailing address of this corporation shall be P.O. Box 9523, Pensacola, Florida 32513.

ARTICLE III

Purpose

The specific purposes for which this corporation is organized are:

1. The Corporation is a nonprofit corporation under the laws of the state of Florida. The Corporation is not formed for the pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Trustees or Officers, except to the extent permissible under law.

2. The Corporation is organized, and shall be operated exclusively for the following purposes:

a. To establish and operate a charitable organization for the purpose of furtherance and advancement of the Pentecostal Church, a Christian church with its doctrines, teachings and practices.

b. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount of value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income,

principal donate or proceeds or such property, for any of the purposes set forth herein.

c. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE IV **Manner of election of directors**

The manner in which the directors are elected or appointed is as follows:

The Board of Directors are elected annually on Thanksgiving Day of each and every year.

ARTICLE V **Initial registered agent and street address**

The name and the street address of the initial registered agent is Annie W. Causey, 3400 West Bobe Street, Pensacola, Florida 32505.

ARTICLE VI **Incorporators**

ARTICLE VII **Amendment**

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Trustees and Officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Florida, as amended from time to time, unless more specific provisions for amendments are adopted by the Corporation pursuant to law.
