**ARTICLES OF INCORPORATION
A NON PROFIT ORGANIZATION**

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation pursuant to Chapter 617, Florida Statutes, providing for the formation of a corporation for non-profit, with the powers, rights, privileges and immunities hereafter mentioned, and we hereby make, subscribe and acknowledge and file with the Secretary of the State of Florida.

ARTICLE I

The name of the corporation is: **United Temple of God Ministeries, Inc.**, and the initial principal address of the corporation is: **545 NW 9th Avenue, Fort Lauderdale, Fl 33311.**

ARTICLE II

The period of duration of this corporation is perpetual unless dissolved according to the law. Corporate existence shall commence upon filing with the Secretary of State.

ARTICLE III

Notwithstanding any other provision of these Articles, the purpose for which the organization is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(C)(3) of the Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not premitted to be carried on by an organization exempt from Federal Income Tax under Section 501(C)(3) of the present Internal Revenue Code, or the corresponding provision of any future United States Internal Law.

ARTICLE V

The qualifications for members and the manner of their admission are: The provision for qualification of members and manner of their admission is to be provided for in the Bylaws.

ARTICLE VI

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (C)(3) and 170(C)(2) of the present Internal Revenue Code, or to the Federal, State, or Local government for exclusive public purpose.

ARTICLE VII

The street address and city of the initial registered office of the corporation is 5351 NW 12th Street, Lauderhill, Fl 33313, and the name of its initial registered agent at such address is Pastor Alonza B. Jones, Jr.

ARTICLE VIII

The number of Directors constituting the initial Board of Directors of the corporation is 4, and the members of the Board of Directors shall be elected and hold office in accordance with the ByLaws. Members of this Corporation may provide such Bylaws for the conduct of its business and the carrying out of its purpose as they deem from time to time.

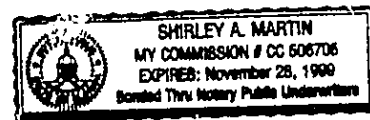
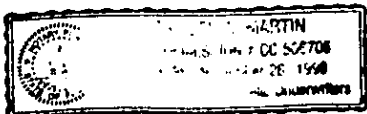
