7 (a corporation not for profit)

8 WE, the undersigned subscribers to these Articles of Incorporation, each
9 a natural person competent to contract, hereby associate themselves together
10 in order to form a CORPORATION NOT FOR PROFIT under the provisions of
11 § 607 of the Florida Statutes, with all the powers, rights, privileges, and
12 immunities; and to that end we do, by these Articles, set forth:

13 **ARTICLE I - NAME, ADDRESS AND AGENT**

14
15 The name of this corporation shall be:

17 tores en Cuba, Inc.

18 (hereinafter referred to as "the corporation"). Its Registered Office shall be
19 located at 13801 S.W. 34th. Street, MIAMI, FLORIDA 33175.

22 **ARTICLE II - TERM OF EXISTENCE**

23 The corporation's term of existence or duration shall be perpetual.

25 **ARTICLE III - PURPOSES**

27 The purpose or purposes for which the corporation is organized are as
28 follows:

2 INTERNATIONAL CENTER FOR INFORMATION
3 AND
4 LIAISON OF THE OPPOSITION GROUPS IN CUBA

5 This organization is represented by the political thoughts of the Cuban democratic exile that with
6 different past and present militants maintain the duty and obligation of striving for the establishment of
7 free and sovereign republic based on the fundamental principles found in the Constitution of 1940

8 The individuals that compose this organization are made of respected Cubans and Cuban-
9 American community leaders, free of protagonism and personal ambitions. Their sole intention is to serve
10 God and their country and to obtain national reconciliation and the reunification of the Cuban family.
11 This group presently maintains a close relationship with the "Consejo Cubano" and other opposition
12 groups within Cuba.

13 We are deeply concerned with the deteriorating economic and political situation in Cuba. We
14 strongly feel that the citizens in Cuba can no longer survive under the harsh and inhumane conditions
15 which they have been subjected to. Morally, we can no longer allow this suffering and misery to continue.
16 It is time to bring an end to this calamity by creating a proactive policy that could lead to the
17 transformation of Cuba from a communist regime into a free, democratic and sovereign republic

18 **GOALS:**

19 To unify all the efforts that could lead to a transformation of the present communist regime in
20 Cuba towards a democratic and sovereign republic

21 **OBJECTIVES:**

- 22 1. To obtain the support and cooperation of the Latin American nations toward a democratic
23 change in Cuba
- 24 2. To support all the dissidents and human rights groups in Cuban that seek a change towards a
25 democratic system
- 26 3. To keep the international public opinion as well as the human rights organizations informed
27 of the persecutions and imprisonment suffered by members of the opposition groups in Cuba
28 for trying to have a peaceful, democratic change in Cuba
- 29 4. To cooperate and help the United States Government in obtaining the support of the Latin
30 American nations in regards to the U.S. policy towards Cuba that will lead to a democratic
31 and independent republic
- 32 5. To create a news agency that will establish a liaison within each Latin American nation's
33 major media network for the purpose of raising the awareness of the public in regards to the
34 present Cuban situation and obtaining a positive and supportive public opinion towards a
35 democratic change in Cuba
- 36 6. To establish a radio program that will be geared towards the military, the youth, the
37 professional sector, and the general public of Cuba for the purpose of gaining support in
38 preparation and development for a democratic change in Cuba

ARTICLE IV - QUALIFICATIONS OF MEMBERS

The membership of this corporation shall constitute all persons hereinafter named as subscribers and such persons as from time to time hereafter, may become members. The qualifications of members shall be determined by the Board of Directors and admission of new member shall be later approved at a special meeting called for that purpose.

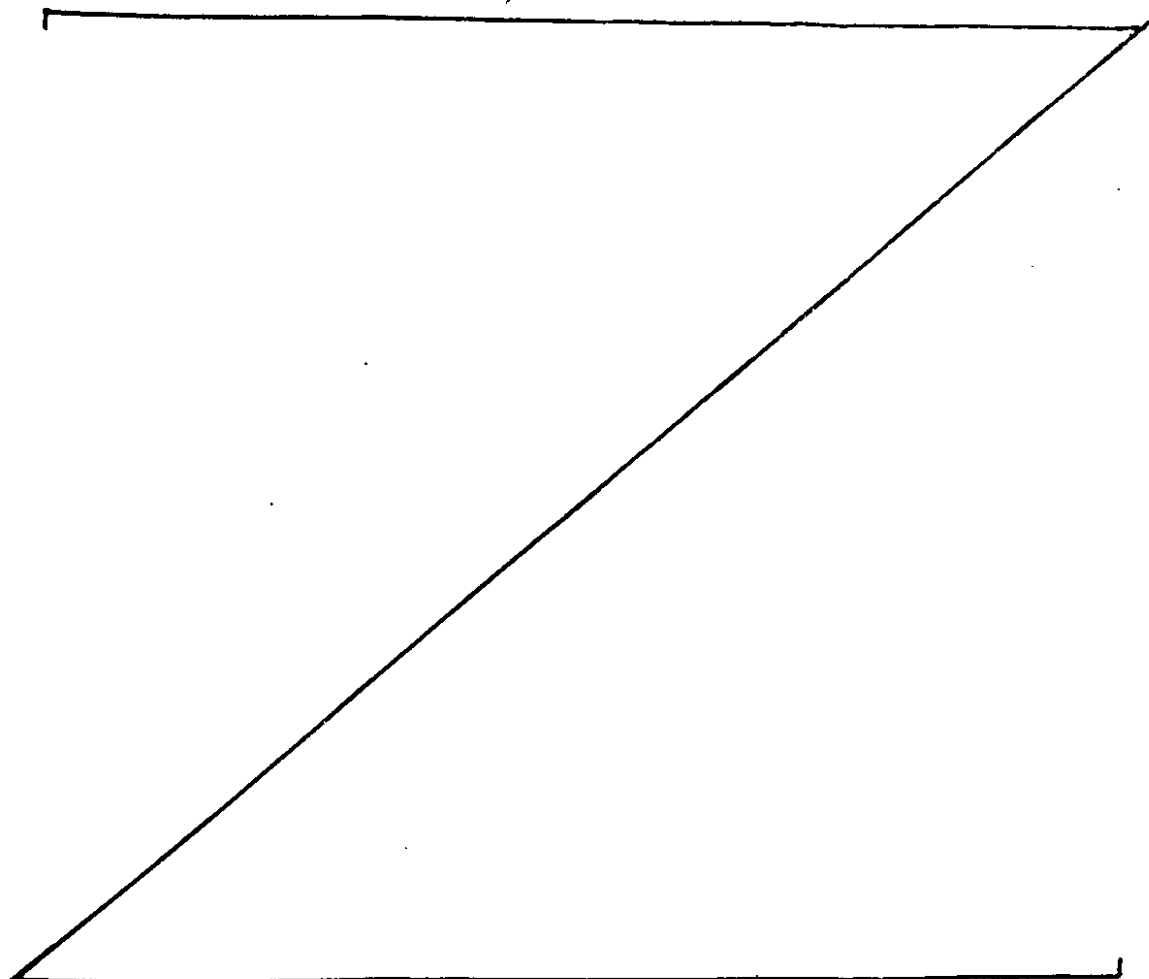

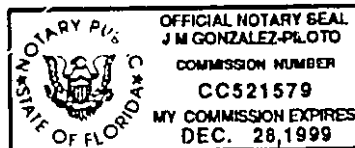
