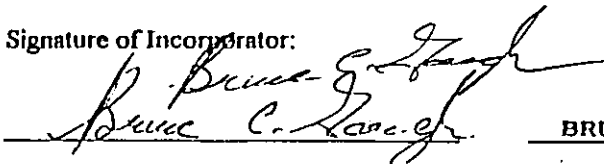

ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

AMERICAN NATURALIZATION TESTING SERVICE, INC.

The undersigned incorporators, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation shall be American Naturalization Testing Services, Inc. Its mailing address shall be 2100 N. Ninth Avenue, Pensacola, Florida 32503.

**ARTICLE II - GENERAL NATURE OF BUSINESS**

The purpose for which the Corporation is organized are:

1. To assist legal aliens in obtaining United States citizenship through education and testing and to assist legal aliens and naturalized United States citizens to adapt to and become successful in their new cultural environment.

2. Notwithstanding any other provisions of these articles, the purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

3. Notwithstanding any other provision of these articles,

this organization shall not carry on any activities not permitted to be carried on by any organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

4. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### **ARTICLE III - DATE OF COMMENCEMENT AND TERM OF EXISTENCE**

This corporation shall commence existence on August 1, 1996, and shall exist perpetually.

#### **ARTICLE IV - INITIAL REGISTERED AGENT AND REGISTERED OFFICE**

The initial street address of the registered office of this corporation in the State of Florida will be 2100 N. Ninth Avenue, Pensacola, Escambia County, Florida 32503. The Board of Directors may from time to time move the registered office to any other address in the State of Florida. The name of the initial



registered agent of the corporation is Bruce C. Gough and he can be served with legal process on behalf of the corporation at 2000 Garcon Point, Milton, Florida 32583. The Board of Directors may from time to time designate a new registered agent.

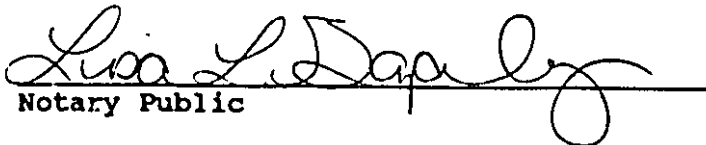

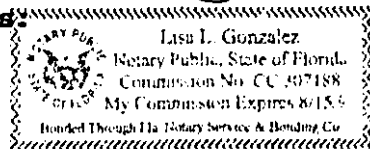

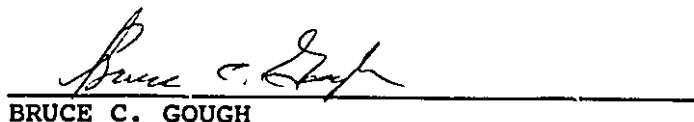
