**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
GTH FELLOWSHIP FOUNDATION, INC.  
(A Florida Corporation Not for Profit)**

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation:

**I**

The name of the corporation is GTH Fellowship Foundation, Inc. (the "Corporation"), filed on August 5, 1996, under Document Number N96000004069.

**II**

The following amendment to the Articles of Incorporation was approved by the sole member and all of the directors of the Corporation by written consent dated November 13, 2013. The number of votes cast for the amendment by the sole member was sufficient for approval.

**III**

Article I of the Corporation's Articles of Incorporation is hereby deleted in its entirety and replaced by a new Article I as follows:

Article I: The name of the corporation is GT Holly Skolnick Fellowship Foundation, Inc.

**IV**

Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

**V**

The effective date of this amendment shall be upon the filing of these Articles of Amendment.
