ARTICLES OF INCORPORATION (NOT FOR PROFIT)

The undersigned Incorporator, a natural person, competent to contract, hereby makes, subscribes, acknowledges and billes these. Articles of Incorporation for the purpose of creating a corporation (not for profit) under Florida Statutes Chapter 617, and do hereby make and adopt the following Articles:

ARTICLE I NAME

The name of the corporation shall be:

"PRIMERA IGLESIA METODISTA UNIDA HISPANA DE TAMPA, INC."

("FIRST UNITED METHODIST CHURCH HISPANIC OF TAMPA, INC.")

ARTICLE II NOT FOR PROFIT
