ARTICLES OF INCORPORATION  
OF  
CORAL GABLES INTERNATIONAL JUNIOR CHAMBER OF COMMERCE, INC.  
A Corporation Not For Profit

ARTICLE I - NAME

The name of this corporation is: CORAL GABLES INTERNATIONAL JUNIOR CHAMBER OF COMMERCE, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of carrying out a charitable organization and young mens and womans leadership training and community development program, and all matters related thereto.

ARTICLE III - NONSTOCK CORPORATION

This corporation shall be organized upon a nonstock basis. The corporation may evidence membership in this corporation by the issuance of membership certificates which shall contain a statement that the corporation is a nonprofit corporation.

ARTICLE IV - SUBORDINATION AND AUTHORITY

This corporation shall be subordinate to and subject to the authority of the United States Junior Chamber of Commerce.

ARTICLE V - MEMBERSHIP QUALIFICATION

In order to qualify as a member of this corporation, an individual must be of high moral character and good reputation in the community and pay the membership fee as established from time to time by the Board of Directors. Membership shall not be transferable and shall be regulated as provided for in the bylaws.

ARTICLE VI - PRINCIPAL OFFICE

The principal office of the corporation is: 400 University Drive, Coral Gables, FL 33134.

ARTICLE VII - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the corporation is: 2151 Le Jeune Road, Mezzanine Floor, Coral Gables, Florida 33134-4200 and the name of the initial registered agent of this corporation at that address is: Gus Suarez, Esq.

ARTICLE VIII - BOARD OF DIRECTORS

This corporation shall have three (3) directors initially. The number of directors may be either increased or diminished from time to time as provided for in the bylaws, but shall never be less than three (3). Directors shall be elected by the members of the corporation. The name and address of the initial directors of this corporation are: Ana Medina, 2809 Bird Avenue, Suite 312, Miami, FL 33133; Richard Weiner, 2809 Bird Avenue, Suite 312, Miami, FL 33133; and Debbie Saunders, 2809 Bird Avenue, Suite 312, Miami, FL 33133.

ARTICLE IX - DURATION

This corporation shall have perpetual existence commencing at the time of filing of the Articles of Incorporation with the Secretary of State.

ARTICLE X - INCORPORATORS

The name and address of the person(s) signing these Articles of Incorporation is/are: Richard Weiner, 2809 Bird Avenue, Suite 312, Miami, FL 33133.

ARTICLE XI - BYLAWS

The power to adopt, amend or repeal the bylaws shall be vested in the Board of Directors.

ARTICLE XII AMENDMENT TO ARTICLES OF INCORPORATION

The Articles of Incorporation may be amended as provided by law.

ARTICLE XIII - VOTING RIGHTS

The entire voting power for the election of directors and for all other purposes shall be vested in the members of the corporation.

ARTICLE XIV - GENERAL OPERATION PROCEDURES

The affairs of this corporation shall be conducted by the incorporators until such time as the corporation holds its first meeting of the Board of Directors. The authority of the incorporators shall include: 1) the adoption of the Articles of Incorporation, and 2) such other activities as are necessary to the administration of the affairs of this corporation during the period of time prior to the meeting of the first Board of Directors. Once the corporation holds the first meeting of the Board of Directors, the affairs of this corporation shall be conducted by the members and the Board of Directors according to law.

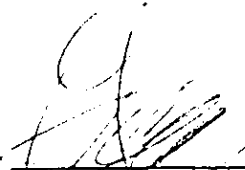
