The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of incorporation:

ARTICLE I NAME

ARTICLE III PURPOSE

BUSINESS AND VOCATIONAL INSTITUTE IS CREATED AND EXISTS FOR THE SOLE PURPOSE OF REACHING OUT TO TROUBLED FAMILIES AND INDIVIDUALS AND HELPING THEM TO GET THEIR LIVES TOGETHER, TO GET THEIR FAMILIES TOGETHER, TO LEARN HOW TO FACE LIFE AND COPE WITH IT'S PROBLEMS AND CHALLENGES; AND, TO TURN THEM INTO GOOD, PRODUCING CITIZENS; RATHER THAN TO REMAIN A DRAIN ON OTHER CITIZENS THROUGH CRIME, ABUSE AND WELFARE.

IT IS OUR ENDEAVOR TO ACCOMPLISH THIS GOAL BY THE BASIC "REMOLDING" OF THEIR OUTLOOK ON LIFE AND THE WAY THEY THINK, THE WAY THEY ACT AND RE-ACT; FREEING THEM FROM ENSLAVEMENT TO DRUGS AND ALCOHOL, TRAINING THEM IN A TRADE TO MAKE THEM SELF-SUFFICIENT, AND TO LEAVE NO STONE UNTURNED IN THE REHABILITATION AND SALVAGE OF EACH INDIVIDUAL.

TO ACCOMPLISH THIS, WE WILL BE HOUSING, FEEDING AND CLOTHING THESE FAMILIES, AS WELL AS TAKING CARE OF THEIR MEDICAL AND DENTAL NEEDS, AND OPERATING A SCHOOL FOR THE FAMILY. WE WILL BE ESTABLISHING AND OPERATING ANY OTHER PROGRAMS THAT WILL HELP US TO MEET OUR GOALS OF RECLAIMING THESE FAMILIES TO SOCIETY.
