ARTICLES OF INCORPORATION
OF
SARASOTA CHURCH OF RELIGIOUS SCIENCE, INC.

The undersigned, a natural person competent to contract, desiring to form a corporation not for profit pursuant to the provisions of Chapter 617, Florida Statutes, does hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

ARTICLE I
CORPORATE NAME

The name of this corporation shall be:

Sarasota Church of Religious Science, Inc.

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of this Corporation is: 5669 Country Lakes Drive, Sarasota, FL 34243.

ARTICLE III
PURPOSES

The purposes for which this Corporation is formed are:

To advance the knowledge and practice of Religious Science among all people, especially among its members, and to foster their fellowship and cultural and social well-being.

To conduct and promote religious, educational, charitable and other activities consistent with the aforesaid purposes.

To hold church services.

To conduct religious educational classes, seminars and workshops.

To acquire, lease, rent, hire, construct, own, maintain and/or otherwise provide a place or places for the conduct of church services and other activities, including office activities.

To sell and/or otherwise make available religious and other books, magazines, pamphlets, tapes and other materials consistent with the Corporation's purposes.

This Corporation is organized and operated exclusively for religious, educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (hereinafter referred to as the "Internal Revenue Code").

This Corporation shall not carry on any activities not permitted to be carried on: (a) by a corporation described in Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation described in Section 170(c)(2) of the Internal Revenue Code.

ARTICLE IV TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V BOARD OF TRUSTEES

Except as otherwise provided by or in accordance with the Bylaws, the business and affairs of this Corporation shall be managed by its Board of Trustees. The initial Board of Trustees shall consist of eight (8) members. The names and addresses of the members of the first Board of Trustees are:

The members of the First Board of Trustees (who shall also be members of this Corporation) shall hold office until their respective successors are elected and qualified as provided in the Bylaws of this Corporation. The number of Trustees of this Corporation set forth in these Articles of Incorporation shall be the authorized number of Trustees until that number is changed by or in accordance with the Bylaws of this Corporation, but shall never be less than three (3).

ARTICLE VI INITIAL REGISTERED OFFICE AND AGENT

The address of the initial Registered Office of this Corporation is: 5669 Country Lakes Drive, Sarasota, FL 34243. The name of the initial Registered Agent of this Corporation at that address is Judith Churchman.

ARTICLE VII INCORPORATOR

The name of the person signing these Articles of Incorporation as the Incorporator is Judith Churchman and her street address is 5669 Country Lakes Drive, Sarasota, Florida 34243.

ARTICLE VIII MEMBERS

The classes of and qualifications for members of the Corporation and the manner of their admission and termination shall be regulated by the Bylaws of the Corporation; provided, however, that the Board of Trustees may authorize a class of honorary members consisting of persons under the age of 18 years, who shall not have voting or other participatory rights in the affairs of the Corporation and who shall be admitted to such membership only with the prior consent of a parent, legal guardian or person having legal custody of said person.

ARTICLE IX BYLAWS

The Board Of Directors shall adopt Bylaws consistent with these Articles of Incorporation. The Bylaws may be altered, rescinded or added to, or new Bylaws may be


adopted as provided in the By-laws

ARTICLE X
DEDICATION OF ASSETS

The property of this Corporation is irrevocably dedicated to the purposes of the Corporation and no part of the net income or assets of the Corporation shall ever inure to the benefit of any trustee, director, officer or member thereof, or to the benefit of any private individual. Upon the dissolution of this Corporation, all assets remaining on hand, after the payment of and/or making provision for the debts, expenses and liabilities of the Corporation, shall be distributed to Religious Science International provided that said organization is then in existence and is then exempt from Federal Income Taxation by reason of its being an organization described in Section 501(c)(3) of the Internal Revenue Code or in similar provisions of any future Federal revenue law, or, if such is not then the case, to any such organization as shall be selected by the Board of Trustees of this Corporation and which is described in Sections 501(c)(3) of the Internal Revenue Code, or in the similar provisions of any future Federal revenue law.

The private property of the incorporator, trustees, officers or members of this Corporation shall not be subject to payment of the Corporation's debts in any event or to any extent whatsoever.

IN WITNESS WHEREOF, I, the undersigned, being the Incorporator hereinbefore named, for the purpose of forming this corporation not for profit under the laws of the State of Florida, do make and file these Articles of Incorporation, hereby declaring and certifying that the facts herein stated are true and hereunto set my hand and seal this 5 day of August, 1996


