ARTICLES OF INCORPORATION  
OF  
FIRST BAPTIST CHURCH OF FORT LAUDERDALE  
PERFORMING ARTS, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

Article I - Name

The name of this corporation shall be: FIRST BAPTIST CHURCH OF FORT LAUDERDALE PERFORMING ARTS, INC.

The principal place of business of this corporation shall be: 301 East Broward Boulevard, Fort Lauderdale, Florida 33301.

Article II - Duration

The period of the duration of this corporation is perpetual, unless dissolved according to law.

Article III - Purpose

The corporation is organized for cultural, religious, benevolent, and educational purposes, as well as any other lawful purposes permitted by a not for profit corporation under Florida law.

Article IV - Board of Directors

The Board of Directors shall be appointed as set forth in the by-laws of the corporation and the corporation shall have an initial Board of Directors consisting of five (5) persons. The number of Directors may either increase or diminish from time to time as provided for in the by-laws, but the corporation must never have fewer than three (3) Directors. 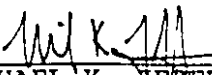

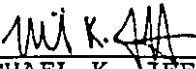
