ARTICLES OF INCORPORATION  
OF

NOW FAITH MINISTRIES, INC.  
A Florida Nonprofit Corporation

The undersigned, acting as Incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE - NAME

The name of this corporation is Now Faith Ministries, Inc. (hereinafter referred to as the "Corporation").

ARTICLE TWO - DURATION

The duration of the Corporation is perpetual.

ARTICLE THREE - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business shall be: 602 McClelland St., Crestview, FL 32536; and the mailing address of the Corporation shall be: P.O. Box 188, Paxton, FL 32538-0188.

ARTICLE FOUR - PURPOSE

The specific purpose(s) for which the Corporation is organized is: to come together to fellowship as a church family to worship God.

ARTICLE FIVE - MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors are elected or appointed shall be stated in the By-Laws.
