Articles of Incorporation of Bible Media Group, Inc. a Florida Non-Profit Corporation

Article 1. Name:

The name of the corporation is: Bible Media Group, Inc.

Article 2. Duration:

The duration of the corporation is perpetual.

Article 3. Purposes:

The purpose of the corporation is to communicate the Christian Gospel of salvation through Christ, as set forth in the King James Bible, to the community at large through various available advertising and/or communication mediums in obedience to the command of our Lord (Matthew 28:18-20). Therefore and hereunder, the message of the Bible Media Group will not contradict, in any manner or form, the following fundamentals of the historic Christian Faith:




