The undersigned acting as incorporation of a not-for profit corporation pursuant to chapter 607 050 of the Florida Statutes adopt the following articles of incorporation of such corporation

Article I Name

The corporate name shall be MIPALA, INC.

Article II Address

The address of the corporation shall be 10752 S W. 5 St Apt # 2 Miami Fl 33174.

Article III Duration

The duration of the corporation shall be perpetual

Articles IV Purpose

The MIPALA shall be established for the following purposes

- 1) To Plan develop and promote Miskito Culture through program in the State of Florida and throughout the World in all area of the arts and humanities.
- 2) To locate and receive funding for the establishment and continuation of Miskito cultural program in the State of Florida.
- 3) To act as a communication bridge among the Miskito communities in the state of Florida and in the World
- 4) To encourage and support scholarship and other educational programs and research pertaining to Miskito Cultural and History, including but not limited to the maintenance of facilities and programs for instructions, research and public performance of all forms of Miskito culture and history

- 5) To act as a representative for the Miskito community in matter and issues relating to or affecting the cultural life and activities of the Miskito communities
- 6) To provide and protect all forms of Miskito tradition, heritage, customs, language, arts, music, dance and other forms of culture
- 7) Such other lawful purpose, acts or activities may be permitted by the general corporation law of Florida and that will benefit in all ways the members of the Miskito tribe
- 8) The corporation is organized exclusively for one or more purposes as specify in section 501(c)(3) of the Internal Revenue Code, including, for such purpose, and making and distributions to organization that qualify as exempt organization under section 501(c)(3) of the Internal Revenue code or corresponding section of any feature federal tax code

Article V Election of Directors

The election of the Board of Directors of MIPALA shall be set fourth in bylaws

Article VI Registered Agent

The address of the registered office is 10752 S W 5 St

Article VIII Additional Provisions

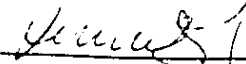

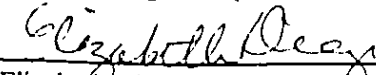
No substantial part of the activities of this corporation shall consist of carrying on propaganda, or

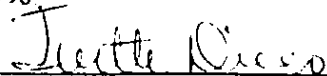
