

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such Corporation:

ARTICLE I

The name of the corporation shall be:

The principal place of business of this corporation shall be:

The period of the duration of this corporation is perpetual, unless dissolved according to law.






