ARTICLES OF INCORPORATION

OF

FLORIDA JEWISH THEATRE, INC.

(A Corporation Not For Profit)

WIG 15 /W II: 3

ARTICLE I

We, Alan Jacobson and Melissa Boher Jacobson, whose address is 3341 Pit.; Hill Trail, Palm Beach Gardens, Florida 33418, and Andrew M. Jacobson, whose address is 12700 Whitey Street, Wellington, Florida 33414, all being at least eighteen (18) years of age, are hereby forming a non-stock not-for-profit corporation under and by virtue of Chapter 617 of the Florida Statutes.

ARTICLE II

The name of the Corporation (which is hereafter called the "Corporation") is **FLORIDA JEWISH THEATRE, INC.**

The address of the initial principal office of the Corporation in this State is 224 Datura Street, Suite 404, West Palm Beach, Florida 33401.

The name and address of the Registered Agent of the Corporation in this state is Alan Jacobson, 3341 Pine Hill Trail, Palm Beach Gardens, Florida 33418. Said Registered Agent is an individual actually residing in this State.

The names and addresses of the Incorporators are as follows:

Alan Jacobson and Melissa Boher Jacobson, both of 3341 Pine Hill Trail, Palm Beach Gardens, Florida 33418, and Andrew M. Jacobson, of 12700 Whitey Street, Wellington, Florida 33414.

ARTICLE III

The purposes for which the Corporation is formed are:

The Corporation is organized and shall be operated exclusively for charitable or educational purposes by conducting or supporting activities related to the presentation of theatrical productions. Solely for the above purposes, the Corporation is empowered to exercise all rights and powers conferred by the laws of the State of Florida upon non-profit corporations, including, but without limitation heron, to receive gifts, devises, bequests and contributions in any form, and to use, apply, invest and reinvest the principal and/or income therefrom or distribute the same for the above purposes.

ARTICLE IV

No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to the Corporation's Board of Trustees or officers or to any private individuals, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of valid written agreements and for the purposes set forth in ARTICLE III hereof.

ARTICLE V

It is intended that this Corporation shall have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code and which is other than a private foundation by reason of being described in Section 509(a)(3) of the Code. These Articles of Incorporation shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly. The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to such extent as would result in loss of its exemption from federal income tax under 501(c)(3) of the Code. Nor shall any activity of the Corporation consist of participating in or intervening in political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE VI

The Corporation is not organized for profit; it shall have no capital stock and shall not be authorized to issue capital stock.

ARTICLE VII

The Corporation may have members, the qualifications for membership being enumerated in the By-Laws of the Corporation.

ARTICLE VIII

Upon the dissolution of the Corporation, the Board of Trustees shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, distribute all of the assets of the Corporation exclusively for charitable or educational purposes to the organizations approved by the Corporation. In the event any of such assets are not so distributed, the Board of Trustees shall petition the State court having jurisdiction with respect to the Corporation, and request

such court to distribute such assets exclusively for the aforesaid purposes of the Corporation or to such organizations as

ARTICLE IX

The persons who shall initially serve the Corporation as Trustees for a period of three (3) years or until their successors are duly chosen and qualified pursuant to methods outlined in the Bylaws of the Corporation are as follows:

ARTICLE X

The affirmative vote of a majority of the Board of Directors at any annual or special meeting of the Board of Directors shall be required to adopt or approve the following actions:

Liquidation or dissolution of the Corporation.

Merger, consolidation or transfer of substantially all the assets of the Corporation.

Repeal, modification, amendment, in whole or in part, or addition to the Articles of Incorporation or By-Laws of the Corporation or adoption of new Articles of Incorporation or By-Laws.

The notice of the meeting at which any such action is to be considered shall set forth the subject of the action or actions

ARTICLE XI

All references in these Articles of Incorporation to sections of the Internal Revenue Code shall be considered references to the Internal Revenue Code of 1954, as from time to time amended, and to the corresponding provisions of any similar law subsequently enacted.
