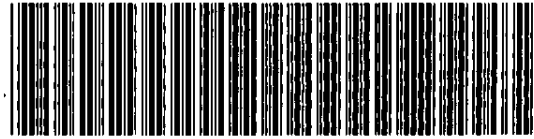

Article Four (Amend)

The purpose for which the corporation is organized is the orderly, progressive, economic diversification of Hardee County, which will insure a superior quality of life through public and private activities.

(a) Notwithstanding any other provisions herein, this corporation is organized exclusively for charitable, educational and scientific purposes, and will not carry on any activities not permitted to be carried on by (a) a corporation exempt from federal income tax under under Section 501(c)(3) of the United States Internal Revenue Code, as amended from time to time, (b) a corporation contributions which are deductible under Section 170(c)(2) of the United States Internal Revenue Code, as income set forth in Section 508(e) or any other section of the United States Internal Revenue Code, as amended. This corporation shall not be involved in prohibited financial transactions with disqualified persons (acts of self dealing) per restrictions set forth in Section 494 and other provisions of the United States Internal Revenue Code, as amended.

(b) The Funds to carry out the purposes of the corporation shall be obtained through donations and any and all means permitted under law.
