ARTICLES OF INCORPORATION  
OF

TRINITY TABERNACLE OF THE True Vine, Inc.  
(a non-profit organization)

We, the undersigned, hereby associated ourselves together for the purpose of becoming a church under the laws of the State of Florida applicable to organizations not for profit and respectfully submit the following proposed ARTICLES OF INCORPORATION for approval:

ARTICLE - NAME

The name of the Church shall be Trinity Tabernacle of the True Vine, Inc., a non-profit Corporation. Its Principal place of business shall be at 4750 N.W. 16th Court, Lauderhill, Broward County, Florida and such other place or places as the Board of Directors may decide from time to time. The name and address of its Resident Agent is Johnny Jones, Sr. of 4750 N.W. 16th Court, Lauderhill, Florida 33313.

ARTICLE II - OBJECTIVES

The general purposes and objectives of this church shall be conduct religious worship and instruction, ministries, school, parsonages and other institution connected therewith of a religious, educational, charitable and benevolent nature to the ends that its own members and others may be generally instructed and educated concerning those articles of faith which are most surely held among true Christian and to advance spiritual growth and the people of the community in which it is located. To promote home and foreign missions, and to aid the spread of the Gospel of Jesus Christ to the end of the earth. To educate, prepare and ordain Christian men for ministry of the Gospel of Jesus Christ, and the purpose of promoting the foregoing objectives.

The further general and specific purposes for which this organization is organize are to qualify it is as an exempt organization under the presently existing Internal Revenue Code or any corresponding provision of any subsequent Federal Tax Laws, including for such purposes, the making of distribution to organizations which qualify as Tax Exempt organization under that code.

### ARTICLE III - MEMBERSHIP

Every person who believes in repentance toward God, and faith in Jesus Christ, as Savior and Lord, and who is willing to acknowledge him publicly as Lord and Savior and Follow Him and to observe the ordinances of Christ and to be governed by His Laws, is qualified and eligible for membership in this organization.

The manner of admission to the membership in said church shall be by letter of dismission from other churches of like faith and order and by satisfactory statement of former membership in one of the churches of like faith and order, and profession of faith as herein provided in this Article III, upon a favorable majority vote of the membership of said organization present at any meeting of said organization.

The present membership of Trinity Tabernacle of the True Vine, Inc. not INCORPORATION and those hereafter admitted to the membership, shall constitute the membership of this organization.

### ARTICLE IV - TERM

This Corporation shall have perpetual existence.

#### ARTICLE VI - OFFICERS

The business affairs of this church shall be managed by the General Board of Directors, such management to be subject to the approval of the organization and said Board to be composed of not less than (4) and said Board of Directors shall be elected from and by the membership of said organization. The term of the membership of said Board of Directors shall be for one (1) year or until their successors are elected and qualified or as for such other length of time as the membership of said organization may provide by its By-Laws. The said Board of Directors shall elect from its own membership, a President, Vice-President, Secretary and Treasure. All elections to the membership on said Board of Directors shall be by majority vote of the members of said church present at any business meeting of the said church. The present Board of Directors of Trinity Tabernacle of the True Vine, Inc., (not incorporated), the incorporators hereof, whose names are set forth shall constitute the Board of Directors and shall hold office until successors are qualified. The present officers of the Board of Directors shall be Johnny Jones, Sr.-President, Karen Jones - Vice President, Tia Lonesome - Secretary, and Johnny Jones, Jr. - Treasurer.

In addition to the Board Directors, the church may provide for such officers as it may deem necessary from time to time, such officer shall be elected by a majority vote of the church, present at any business meeting of said organization for such as the organization may provide by its By-Laws, but not less than one (1) year.

#### ARTICLE VII - OFFICERS

The name of the officers who are to manage all the affairs until the first selection under the Charter are as follows:

#### ARTICLE VIII- BY-LAWS

The By-Laws of the Church are subject to be made altered, or rescinded by the members of the church at any regular business meeting called for that purpose, provided that proper notice has been given at a previous regular business meeting and provided also, that such proposed changes have been submitted to the Board of Directors for their consideration prior to bringing it to the church for consideration. The Board May express approval or disapproval but final action thereon is subject to the vote of the membership of the church body. All such new By-Laws, alteration, changes or recessions must receive an affirmative vote of two-thirds majority of the members present and voting at such meeting.

#### ARTICLE IX - AMENDMENTS

These ARTICLES OF INCORPORATION may be altered, changes or amended by the members of the church body at any regular business meeting for that purpose, provided also, that such proposed changes have been submitted to the Board of Directors for their consideration. The Board may express approval or disapproval but the final action thereon is subject to the vote of the membership of the church. All such proposed alternations, changes of amendments of the ARTICLES OF INCORPORATION, when approved by the by the church body, must be also forwarded to the Secretary of the State of Florida or the proper authority and filed and approved by him before same become effective.

#### ARTICLE X - PROPERTY

The property of this church body is irrevocably dedicated to religious and charitable purposes and no part of the net income or assets of this church body shall ever inure to the benefits of nay director, officer, or member thereof, or to the benefits of any private individual.

#### ARTICLE XI

Upon the dissolution of this church, its assets remaining after payment, or provision for payment of all debts and liabilities of this church, shall be distributed to a non-profit fund foundation, or organization which is organized and operated exclusively for religious or charitable purposes and which has established its tax exempt status under existing applicable laws of the Internal Revenue Code as it exist under Section 501 (c) (3)Federal Tax laws.

WE, THE UNDERSIGNED, being the incorporators of this Church Body, and including all the persons herein named as the subscribers of the Church, for the purpose of forming this non-profit charitable organization under the laws of Florida have executed these ARTICLE OF INCORPORATION on the 24 day of July.

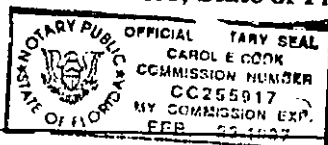

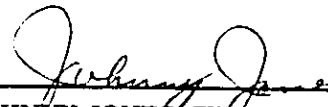

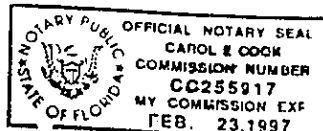
