ARTICLE I

NAME

The name of the corporation is GROVELAND NEIGHBORHOOD
CENTER, INC.

ARTICLE II

PURPOSE

The purposes for which this corporation is organized are exclusively
religious, charitable, scientific, literary and educational within the meaning of
Section 501(c)(3) of the Internal Revenue Service of 1986 or the corresponding
provision of any future United States Internal Revenue law.

ARTICLE III

PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of the corporation shall be located at 153 Mills Street,
Groveland, Florida 3736, and the mailing address is the same.

ARTICLE IV

POWERS

The powers of this corporation shall include all powers provided for by the
laws of the State of Florida. However, notwithstanding any other provisions of
these articles, this organization shall not carry on any activities not permitted to
be carried on by an organization exempt from federal income tax under Section
501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding provision
of any future United States Internal Revenue law.

ARTICLE V

BOARD OF DIRECTORS

The business affairs shall be managed by a board of directors. The
number of directors and manner of their election shall be established in the by-

laws of the corporation, but the corporation shall never have fewer than three (3) directors.

TO

Pursuant to the provisions of Section 617.1006, Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article VIII of the Articles of Incorporation filed August 19, 1996, is hereby deleted.

SECOND: The Articles of Incorporation filed August 19, 1996, are hereby amended by addition of new Articles VIII, and IX as follows:

ARTICLE VIII

DISTRIBUTION OF EARNINGS AND PROHIBITED ACTIVITIES

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or others private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities or organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

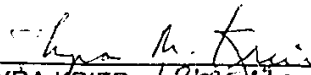
ARTICLE IX

DISTRIBUTION OF ASSETS UPON DISSOLUTION

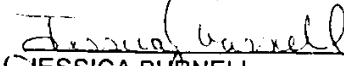
Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

THIRD: There are no members entitled to vote on proposed amendments to the articles of incorporation, and the amendments were adopted by the board of directors of the corporation on October 25, 1996

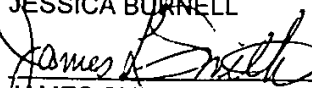

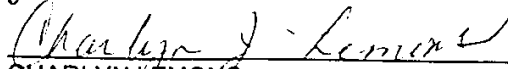

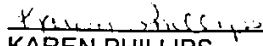
