## ARTICLES OF INCORPORATION

*The undersigned, acting as incorporators of a not for profit corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:*

### ARTICLE I

The name of the corporation shall be:

### ARTICLE III

Purpose:

The corporation is for the explicit purpose of carrying out the "Business" of the church. To manage and control all church funds and funding sources. To make and manage all agreements with respect to church finances, church properties, and church financial obligations. To make contracts and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations for the purpose of procuring land and/or facilities for holding church services, Sunday School classes, church administration offices, etc.
