Articles of Incorporation for National Airboat Racing Club, Inc.

The undersigned, acting as incorporator/founder of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

Article 1

Name

The name of the corporation shall be the:
National Airboat Racing Club, Inc.

Article 2

Duration of Corporation

The duration of the Corporation shall be perpetual.

Article 3

Principle Place of Business & Address

The principle place of business and mailing address of this Corporation shall be:

Article 4

Purpose

The purpose of the Corporation shall be:

To provide a uniform and safe environment for airboat racing. To carryout those things necessary to accomplish the above purpose as permitted by Florida Statutes except that such activities shall not be for profit.

Article 5

Limitation of Powers

The corporate powers of this Corporation are as provided in Sec. 617.0302 Florida Statutes except that the corporate powers cannot be exercised in any way that harms the sport of airboat racing or the sport of airboating.

Article 6

Members

There shall be two classes of membership. These two classes are: Race members and Regular members. The qualifications and rights of the two classes along with quorum and voting requirements and activities of these classes shall be set forth in the bylaws.

Article 7

Election of Directors & Government

The Board of Directors shall consist of Five members and a quorum shall consist of four/fifths members. The initial director is the incorporator/founder and is self appointed, further directors shall be elected and serve according to the bylaws of this Corporation. The further government of this Corporation shall be set out in the bylaws.
