We, the undersigned subscribers, all being of full age, have associated ourselves together for the purpose of forming a corporation not-for-profit, without capital stock, under the provisions of all applicable <u>State of Florida Statutes</u>. We hereby accept all the rights, privileges, benefits and obligations conferred and imposed by said law, and we do hereby, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I

NAME: DELIVERANCE CHURCH OF GOD IN CHRIST, INC.

ARTICLE II

<u>PURPOSE</u>: To operate a religious institution / .hurch), sustain and promote religious Worship, provide for the preaching of the gospel, circulate the Bible and other religious literature.
