OF

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves to form a corporation for non-profit under the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation shall be SOUTHERN INTERDENOMINATIONAL
COALITION INC

ARTICLE I

Object

The general nature of the Corporation shall be:

1. To undertake demonstration projects either alone or with any corporation, association, individual partnership, or public or private agency;
2. To provide technical assistance to domestic or foreign corporations. Whether for or not, for , associations, partnerships or individuals , or to develop and or create housing in Dade County,.
3. To acquire and develop land for housing;
4. To purchase and rehabilitate deteriorating or substandard housing for subsequent rental or re-sale;
5. To enter into a joint venture with any corporation, association, partnership, individual or public or private agency that will increase the supply of decent, safe and sanitary housing in the United States and Puerto Rica.
6. To undertake demonstration projects either alone or in conjunction with any corporation, association, individual, partnership, or public or private agency to promote economic growth throughout the United States and Puerto Rico.

6. To undertake demonstration projects either alone or in conjunction with any corporation, association, individual, partnership, or public or private agency to promote economic growth throughout the United States and Puerto Rico.
7. To provide educational services, counseling and/or technical assistance to residents of the United States and Puerto Rico.
8. To buy and/or sell land, and/or residential units, to persons of low and moderate incomes at prices they can afford;
9. To rent or lease dwelling units and/or businesses at low and moderate process that can be afforded;
10. To purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind, and description and to?

ARTICLE III.

Membership

1. At the annual meeting of members, members may make recommendations for consideration by the Board of Directors pertaining to corporate policy and action programs for the year;
2. Upon receipt of such statement by the Corporation's registered office, the applicant's name shall be placed on the membership roster and he shall, thereafter, be entitled to receive notices of meeting, proxy ballots and to participate in the annual meeting.

ARTICLE IV.

Term

The term for which this Corporation shall exist shall be perpetual.

ARTICLE V.

Directors

1. SOUTHERN INTERDENOMINATIONAL COALITION INC. shall have 7 Directors, all of whom shall be residents of the State of Florida;
2. Four voting Directors shall constitute a quorum for the transaction of business by the Board of Directors.
The manner in which the directors are appointed may be as stated in the By-Laws.

ARTICLE VI.

Officers

1. The affairs of the Corporation shall be managed by a President.
2. The President of the Corporation shall be responsible for the daily management of the Corporation and shall be an ex official member of the Board of Directors. The President shall be appointed by the Board Directors; this appointment of the President shall be at the discretion of the Board of Directors;
3. All legal instruments of the Corporation shall be signed by two officers of the corporation and sealed with the corporate seal, and attested by the Secretary or another Director.

ARTICLE VII.

First Directors and First Officers

The names of the persons constituting the first Board of Directors as well as the officers who are to manage the affairs of this Corporation until their successors are appointed or elected and qualified shall be as follows:

ARTICLE IX.

By-Laws

The By-Laws of the Corporation are to be made, altered, or rescinded by the Board of Directors subject the approval of the members at a special meeting which shall be called for such purpose. The members shall have the right to accept, amend or reject such By-Laws and alteration and/or amendments thereof.
