ARTICLES OF INCORPORATION

OF

(A Florida Corporation Not For Profit)

I, the undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby constitute a Non-Profit Ministry, to operate in accordance with the laws of God and in a non-profit corporate form pursuant to the applicable provisions of the Statutes of the State of Florida relative to corporations not for profit; and Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law and I hereby covenant and agree as follows:

ARTICLE 1 - NAME

The name of this corporation is: IN HIS NAME MINISTRY OF HELPS, INC. and its principal office shall be in the city of St. Augustine, St. Johns County, Florida, or at such other place as the Board of Trustees may decide.

ARTICLE III - TERM OF EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV - PURPOSES

The objectives and purposes for which this Corporation is constituted and organized are:

ARTICLE VIII - CONTRACTS, CHECKS, DEPOSITS AND FUNDS

<u>Section 1</u>. The Board of Trustees may authorize any officer or officers, agency or agents of the corporation, to enter into contracts or execute and deliver instruments in writing in the name of and on behalf of the corporation and such authority may be general or confined to specific instances.

<u>Section 2</u>.
