ARTICLES OF INCORPORATION

OF

INTERNATIONAL FOUNDATION OF CUBAN POLITICAL PRISONERS, INC. C. 2: 1

A FLORIDA NONPROFIT CORPORATION

- Article 1 Name. The name of the Corporation is: INTERNATIONAL FOUNDATION OF CUBAN POLITICAL PRISONERS, INC.
- Article 2 Duration. The durattion of the Corporation is perpetual
- Article 3. Purposes. The purposes of the corporation is a fo-
- A. This corporation is a not for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are the following:
- 1.- To Raise Funds for the provision of medical supplies to Cuban Political Prisonersainside Cuba.
- 2.- To raisw Funds for the numanitarian and economic assistance of former Cuban political. Prisoners living outside of Cuba as well as Individuals and groups of Cuban Nationality living AS exiles outside of Cuba in nations other than the United States who find themselves in conditions of Economic Distress.
- 3.- To serve as an avocate for the basic human rights of the individuals and groups describes above in sub-paragraphs l and 2
 - B.To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
 - C.Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the internal Revenue Code and no part of the net earnings of the Corporation shall insure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make pay ments and distributions in furtherance of its stated purposes

Article 4. Members. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Eylaws, but who shall not have the right to vote.
