Notice is hereby given that the undersigned subscriber of these Articles of Incorporation desiring to form a corporation not for profit, without capital stock, under the provisions of Chapter 617, Florida Statutes does hereby accept all of the rights, privileges, benefits and obligations conferred and imposed by such law, does hereby make, subscribe, acknowledge and file these Article of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be TEMPLE MISSIONARY BAPTIST CHURCH OF RIVIERA BEACH, INC., located at 1044 West 31st Street, Riviera Beach, Florida 33404. The mailing address of the corporation shall be 1044 West 31st Street, Riviera Beach, Florida 33404.

ARTICLE II

DURATION

The corporation shall have a perpetual existence unless sooner dissolved according to law.

ARTICLE III

CORPORATE PURPOSE

The specific purpose for which the corporation is organized is to raise, receive and maintain a fund or funds of personal property and to distribute and administer the fund or funds including any income or interest generated therefrom, exclusively for education, literary, charitable, scientific and religious purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Revenue Law.

ARTICLE IV

MEMBERS

Any person shall be eligible for membership in this corporation upon application and approval as provided in the by-

laws of the corporation.

ARTICLE V

REGISTERED OFFICE AND AGENT

Any such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
