ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of this Corporation shall be Breaking The Silence Metropolitan Community Church, Inc.

ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

Purpose(s)

The specific purpose for which the corporation is organized is: to worship God, to preach the Gospel of Jesus Christ, to celebrate the sacraments, to realize Christian community and unity within this church and the Church Universal, to be totally inclusive in ministry and worship style, to render loving service to all people, and to strive for righteousness, equality, justice and peace.

This church will exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit organizations. Provided, however, that this church shall not engage in any action which is not permitted to be carried on by nonprofit organizations under the Internal Revenue Code.

ARTICLE IV

Manner of election of directors

1. The manner in which the directors are elected shall be stated in the By-Laws of Breaking the Silence Metropolitan Community Church, Inc.

ARTICLE V
Limitation of corporate powers

The government of this corporation is vested in its members, who exercise the right of control in all its affairs. We are an affiliate of the UNIVERSAL FELLOWSHIP OF METROPOLITAN COMMUNITY CHURCHES within the Southeast District. We are also subject, however, to Laws of the State of Florida relating to corporations not for profit.


