# ARTICLES OF INCORPORATION OF

# "MIKA" - DEFORE THEIR TIME, INC. (A Florida Corporation Not For Profit)

## ARTICLE I. NAME

The name of the corporation shall be "MIKA" - BEFORE THEIR TIME, INC.

#### ARTICLE II. DURATION

The duration of the corporation shall be perpetual and its existence shall commence on the 27th day of August, 1996.

#### ARTICLE III. PURPOSE

The corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or the corresponding portions of any future United States Internal Revenue Law), including, to the extent permitted by Section 501(c)(3), the provision of counseling and other assistance to the surviving family and loved ones of victims of violent crime to enable them to better cope with their loss, and the provision of scholarships to assist disadvantaged students in obtaining a college or junior college level education.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

The corporation is and shall remain a corporation not for profit. The corporation shall not have nor issue shares of stock.

No dividends shall be paid and no part of the net earnings of the corporation shall inure to the benefit of its members, directors or officers, or to the benefit of any private individual.

## ARTICLE IV. PRINCIPAL OFFICE

The street address of the initial principal office of the corporation and the mailing address of the corporation are 5835 Wickford Lane, Pensacola, Florida 32526.

## ARTICLE V. BOARD OF TRUSTEES

The corporation shall initially have three trustees. The number of trustees may be increased or decreased from time to time by the bylaws, but shall never be less than three. The method of election of trustees shall be as stated in the bylaws.

### ARTICLE VI. INCORPORATOR

The incorporator of the corporation is Joyce F. Johnson, whose address is 5835 Wickford Lane, Pensacola, Florida 32526.

### ARTICLE VII. REGISTERED AGENT

The initial registered agent of the corporation is the law firm of RAY, KIEVIT & KELLY, P.A., 15 West Main Street, Pensacola, Florida, 32501.

### ARTICLE VIII. BYLAWS

The Board of Trustees may provide such bylaws for the governing of the corporation and the carrying out of its purposes as it may deem necessary. The bylaws may be repealed or amended, and new bylaws may be adopted, by the Board of Trustees.

## ARTICLE IX. DISTRIBUTION OF ASSETS UPON DISSOLUTION

No person, firm or corporation shall ever receive any dividends or profits from the undertakings of the corporation. In the event of dissolution, the residual assets of the corporation shall be turned over to one or more organizations which themselves are exempt as organizations described Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code or the corresponding sections of any prior or future United States Internal Revenue Law, or to state or local government for exclusive public purposes, and none of the assets shall be distributed to any member, director or officer of the corporation.

#### ARTICLE X. AMENDMENT

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment thereto.
