Articles of Incorporation

The undersigned, acting as incorporators of a corporation not for profit pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

Article I

Name

The name of this corporation shall be: World Peace and Relief Team of America, Inc.

Article II

Principal Place of Business and Mailing Address

The principal place of business and mailing address of this corporation shall be:

Article III

Terms

This corporation shall be a non-membership corporation, and shall exist perpetually unless dissolved by due process of law or the adoption of articles of dissolution by the Board of Directors.

Article IV

Statement of Purpose

World Peace & Relief Team of America is a voluntary humanitarian aid organization committed to helping people in regions affected by war, poverty, famine, cultural oppression, natural disasters, and other exigencies. World Peace & Relief Team of America strives to meet the material, societal, and personal needs as determined by target groups; and to raise awareness of their plight in the hope of encouraging others to take similar action.

Article V

Manner of Election of Directors

A person being considered for a position on the Board of Directors shall be nominated by a residing director and elected by a majority vote by the Board of Directors. The manner in which the directors are appointed may be as stated in the By-Laws.

Article VI

Limitation of Corporate Powers

The corporate powers of this corporation are as provided in section 617.0302, with the following exceptions, unless limited through amendment to these articles of incorporation:

(1) No part of the net earnings of the corporation shall inure to the benefit of any director, officer of the corporation, or representative of the corporation(reasonable compensation may be paid for services rendered to or for the corporation effecting one or more of its purposes). No director, officer of the corporation, or representative of the corporation shall be entitled to share in the distribution of any part of the corporate assets on dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

(2) Notwithstanding any other provision of these Articles, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue code and its regulations as they exist or as they may hereafter be amended.

(3) Upon the dissolution of this corporation or the winding up of its affairs, the assets of the corporation remaining after payment of all costs and expenses of such dissolution shall be distributed exclusively to organizations which then qualify under the provisions of section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended. None of the assets will be distributed to any officer or director of the corporation or to any private individual.

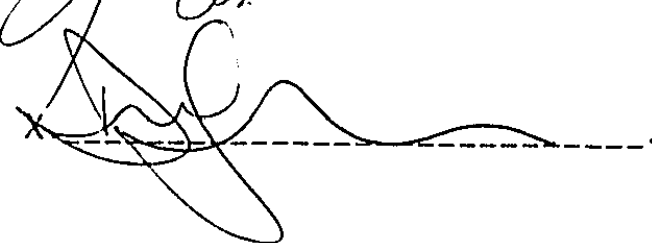
