ARTICLES OF INCORPORATION
OF

FOUNTAIN OF LIFE CHRISTIAN CHURCH, INC. hereby forms a religious corporation not for profit in accordance with the provisions of Chapter 617, Florida Statutes, and all amendments relating thereto and hereby adopts the following articles of incorporation:

ARTICLE I
THE NAME AND ADDRESS

The name of the corporation is FOUNTAIN OF LIFE CHRISTIAN CHURCH, INCORPORATED, with physical address at 85 Alpha, Davenport, Fl. 33837

ARTICLE II
PURPOSE

The purpose of this corporation shall be to operate and maintain a church which is true to the Bible as the infallible Word of God and the only rule of faith and practice; which is pentecostal in doctrine, form and government; and which serves and glorifies Jesus Christ as Lord and Living Savior through all functions of a church in the broadest sense including but not limited to worship, education, discipleship, evangelism, fellowship, and loving care and service to and for its members and to and for a community which is as far and wide as it may effectively reach by whatever means.

ARTICLE III
MEMBERSHIP

Membership of this corporation shall include any person who shall become an active member of FOUNTAIN OF LIFE CHRISTIAN CHURCH, INC. by profession of faith in Jesus Christ or baptism in water, or by transfer from another pentecostal church recognized by our board members as one of a solid Biblical doctrine; provided, however, that when any member of said body shall become unfaithful in his or her support of the programs and ministries of the Church such a person shall cease to be a member in good standing in said body and such person shall cease to be a member of this corporation.

ARTICLE IV
TERM OF EXISTENCE

This corporation shall have perpetual existence, unless dissolved by law.

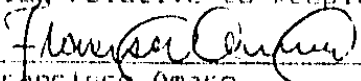

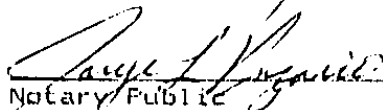
