Except as otherwise provided by statute, a 25% of the Members entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of Members. When a specified matter of business is required to be voted on by a class of Members, except as otherwise provided by statute, a majority of the class shall constitute a quorum for the transaction of such item of business by that class.

Except as otherwise provided by statute, one-third of the members of the Board shall constitute a quorum for the transaction of business.
