Pursuant to §617.013, Florida Statutes, these Articles of Incorporation are created by 4000 Immokalee Corporation, Inc., a Florida corporation, as sole incorporator, for the purposes set forth below.

ARTICLE V.


This corporation is to exist perpetually.



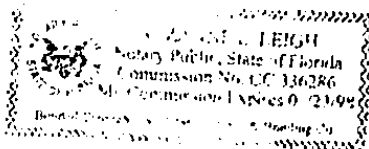


