ARTICLES OF INCORPORATION

Till all

The undersigned, acting as incorporator (s) of a corporation pursuant to chapter 617. Plotidic Statistics [1] 43-44 adopt(s) the following Articles of Incorporation

TALLER STATE

Article 1: Name

The name of the corporation is Hispanic Family Enrichment Center, INC

Article 2: Purposes

- a). To provide clinical services, to provide transitional services, to refer to such services, or both, those in need of counseling intervention to deal with issues affecting the family welfare;
- To provide an awareness of the need for prevention, education and treatment of those suffering from or affected by chemical substance abuse;
- To provide clinical services, to refer for such services, or both, those in need of prevention, intervention, and treatment for chemical abuse;
- To enhance the system for the delivery of services to those suffering from or otherwise affected by chemical substance abuse;
- e). To undertake such additional services as may be necessary and appropriate to care for those in the Central Florida Community who are suffering from mental health problems, alcoholism, drug abuse, family dysfunction and other related problems;
- To engage in such additional activities permitted by law as may be necessary in furtherance of the educational and charitable purposes of the corporation.

Notwithstanding anything of these Article of Incorporation, the corporation is organized and shall be operated exclusively for one or more charitable and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code and no part of the net earning of the corporation shall inure to the benefit of any private shareholder or individual. No substantial part of the activities of the corporation shall consist of lobbying, or attempts to influence legislation by propaganda or otherwise.

Article 3: Members

The corporation shall not have members.

Article 4: Term of Existence

The duration of the corporation shall be perpetual

Article 5: Board of Director

a) The affairs of the corporation shall be managed by a Board of Directors which shall consist of at least three (3) and no more than seven (7) members. The method of election of directors shall be as stated in the bylaws of corporation.

Article 6: Distribution of Assets Upon Dissolution

Upon dissolution, the assets of the corporation shall be distributed solely to one or more organizations determined by the Internal Revenue Service to meet the requirements of section 501(c) (3) of the Internal Revenue Code or any successor provision thereto

Article 7: Incorporation
