The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

**ARTICLE I
Name**

The Name of this corporation is the GREATER MIAMI BOYS CHOIR, INC.

**ARTICLE II
Principal place of business and mailing address**

The address of the principal office and the mailing address for the GREATER MIAMI BOYS CHOIR, INC. is 3470 North West 210th Terrace, Miami, Florida 33056.

**ARTICLE III
Purposes**

The specific purposes of this corporation shall be the promotion, direction and support of a boys choir, based in the greater Miami Florida area, to provide an opportunity for economically dis-advantaged and educationally at-risk, inner city young men to display their talents and achieve success; and to provide chorale, theatrical and musical concerts in Florida, the United States and Internationally. The general purposes of the corporation are to provide any and all necessary support services, including administration, operations, travel and fundraising to fulfill the mission of the Greater Miami Boys Choir. This corporation is established to qualify under Section 501 ©(3) of the Internal Revenue Code as a Tax Exempt Organization.

**ARTICLE IV
Manner of election of directors**

The manner of election of the Board of Directors is prescribed in the Bylaws of the corporation.

ARTICLE V
Limitation of corporate powers

The corporation shall have all the corporate powers authorized under section 617.0302, F.S.

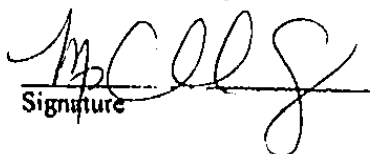

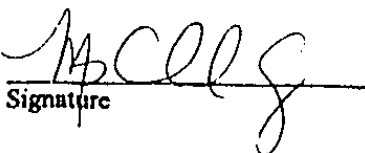

AMENDMENT TO ARTICLES OF INCORPORATION
FOR
GREATER MIAMI BOYS CHOIR, INC.

The Articles of Incorporation have been amended by the Board of Directors and these amendments are to be filed with the Florida Secretary of State's office and a certified copy of such (amended articles) shall be forwarded to the Internal Revenue Service of the United States of America. The amendments are listed below:

The following provisions will be added to ARTICLE III PURPOSES of the Articles of Incorporation for Greater Miami Boys Choir, Inc.:

The purposes for which the corporation is organized are exclusively religious, charitable, and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

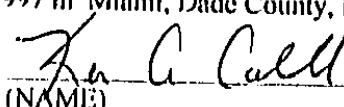
The following provisions will be added to ARTICLE V LIMITATION OF CORPORATE POWERS of the Articles of Incorporation for Greater Miami Boys Choir, Inc.:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

These amendments to the Articles of Incorporation of Greater Miami Boys Choir, Inc. were made at a special called meeting of the Board of Directors for the purpose of amending the corporate articles for tax exempt purposes, held on 7th, January, 1997 at the corporation's principal office in Miami, Florida.

The board of directors constitutes all of the members of the corporation. DATED this 7th Day of January, 1997 in Miami, Dade County, Florida.
