ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **THE CHURCHBELL, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 3808 WEATHERFORD CIRCLE, TITUSVILLE, FL 32780.

ARTICLE III: PURPOSE

To engage in the performance, production, sale and distribution of contemporary christian music.

ARTICLE IV: QUALIFICATION

ARTICLE X: AMENDMENTS

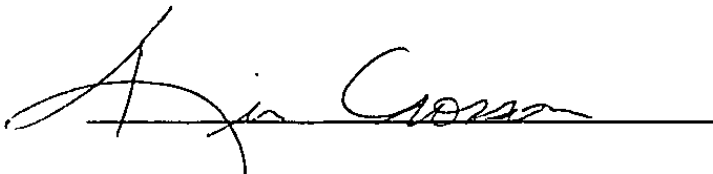
The corporation reserve the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
