ARTICLE I

The name of the corporation shall be CHILDREN'S COALITION FOR CHANGE, INC. (the "Corporation").

ARTICLE II

The street address of the initial principal office and mailing address of the Corporation shall be 888 Boulevard of the Arts #1803, Sarasota, Florida 34236.

ARTICLE III

The purpose for which the Corporation is organized is to establish a proactive family group promoting a new bill of rights for children.

The corporation shall also be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations not for profit may be incorporated under Chapter 617, Florida Statutes, as amended and supplemented.

ARTICLE IV

The initial directors and officers shall be as hereinafter designated:

The corporation shall have all of the powers conferred upon corporations organized pursuant to the provisions of Chapter 617, Florida Statutes, as amended and supplemented.


ARTICLE VI


