## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### ARTICLE I Name

The name of the corporation shall be:

Iglesia Del Senor, Inc.

(The Church of The Lord, Inc.)

### ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

#### Membership

1. A person, in order to be eligible for membership in the corporation shall apply for membership to the Board of Directors of the Corporation.
2. The Board of Directors shall not act on the application and vote whether or not to admit the applicant to membership in the corporation. The applicant to be eligible to apply must first fulfill a three month probational period in the corporation.

### ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The affairs of the corporation are to be managed by a President, a Vice-President, and a Secretary-Treasurer. Said officers with the exception of the President shall serve for a term of one (1) year, or until their successors are duly elected & qualified. The election of directors is according to the By-Laws. Any two of these offices may be combined & held by one person, except the office of President, cannot be combined with the office of the Vice-President or the office of Secretary. Each year the Board of Directors can appoint persons to serve in the Capacity of President, Vice-President, Secretary and Treasurer.

Artículo IV: Iglesia Del Señor, Inc.  
Purpose

The general purpose of this corporation shall be:

- X (a) To organize Missionary work for the teachings of the Gospel of Jesus Christ, within the United States of America, and foreign countries.
- (b) To promote the teachings of the words and Gospel of Jesus Christ among the members of the Church, as well as non-members.
- (c) To ordain Christian workers to visit hospitals, jails and other institutions.
- (d) To secure competent services of Ministers and other persons, with or without compensation to promulgate the Gospel of Jesus Christ.
- (e) To Ordain Ministers and Pastors.
- (f) To rent, lease or purchase such buildings or offices as may be needed by the congregation; to alter or repair the same, and to dispose of same when no longer needed or used by the congregation.
- (g) To purchase, any land or buildings, alter, develop, build or repair the same for the use of the congregation and to dispose of same when no longer in use.
- (h) To purchase, accept, acquire in whole or in part, for any lawful purpose or use, and for and upon lawful consideration, mortgages or other similar instruments and any and all rights thereunder affecting property therein, as well as bonds obligations, debenture, notes, certificates of interest, stocks, and receipts created by any corporation, domestic or foreign, association of firms, trustees, syndicated by governmental division or agencies, and all rights and orders under the same or any of the same.
- (i) To exercise, in respect thereto, any or all rights, powers and privileges or, under, issuing or emanating out of or by reason of ownership or otherwise act thereunder, or in respect thereto of thereof, to do and perform any and all things for the preservation, protection, improvement and enhancement of the IGLESIA DEL SEÑOR, INC.
- (j) To borrow money and to contract debts when necessary for the exercise of its corporation needs, rights, privileges or for any lawful purpose: to mortgage its property, and/or to make and execute deeds of Trust as may be necessary to secure the payment of such obligation or of any debts or contracts for such purposes.
- (k) To make, perform and carry out contracts with any person, firm, corporation, private, public or political body under the government of the United States of America, and foreign countries, so far and to the extent that same made and performed under the privileges allowed by religious corporation laws of the State of Florida.

#### ARTICLE V

##### Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: ...

The foregoing enumeration of activities shall not be construed in no other form but as objectives sought by the Iglesia Del Señor, Inc. (The Church of The Lord, Inc.) and such specific powers herein shall be construed or held to limit or restrict in any manner the lawful powers vested by law in Religious Corporation under the Laws of the State of Florida.


