**ARTICLES OF INCORPORATION  
OF A FLORIDA NON-PROFIT CORPORATION  
ORLANDO OKTOBERFEST, INC.**

KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned, hereby associate together for the purpose of becoming a Corporation Not For Profit and organized solely for general charitable purposes pursuant to the "Florida Corporation Not For Profit Act" set forth in Part 1 of Chapter 617 of the Florida Statutes, providing for the formation, liabilities, rights, privileges, benefits, obligations, and immunities conferred and imposed on Corporations and for the transaction of business with and under the following charter.

ARTICLE I

Name

The name of the corporation shall be ORLANDO OKTOBERFEST, INC.

ARTICLE II

Principal Place of Business and Mailing Address

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

Purpose(s)

The specific purposes for which the corporation is organized are:

1. To present, promote, and educate the public on German culture, music, ethnic crafts, cuisine and festivals;
2. To support financially other not-for profit corporations, educational foundations and other institutions of learning and higher learning.

3. To provide scholarships to students qualified and in need of financial support to pursue their studies of the German language, history and culture; and

4. To foster better German-American relations.

#### ARTICLE IV

##### Manner of Election of Directors and Initial Directors

The manner in which the directors are elected or appointed is as follows:

The Directors shall be elected by the members to serve for terms of two years. The manner by which such elections are to be held shall be stated in the By-Laws.


